

Chundrigar Road, Karachi and Corporate Office at 8th Floor, Executive Tower, Dolmen City, Block 4, Clifton, Karachi, Pakistan (hereinafter called the "Management Company" which expression where the context so permits shall include its successors in interest and assigns) of the one part; and

CENTRAL DEPOSITORY COMPANY OF PAKISTAN LIMITED, a company incorporated under the Companies Ordinance, 1984 and registered with the Securities and Exchange Commission of Pakistan as a central depository company, with its registered office at CDC House, 99-B, S.M.C.H.S., Main Shahra-e-Faisal, Karachi (hereinafter called the "Trustee", which expression, where the context so permits, shall include its successors-in-interest and assigns) of the other part.

WHEREAS:

UBL FUND MANAGERS, as the management company and Central Depository Company as the trustee, executed a Trust Deed dated January 1st, 2013, to constitute "UBL Financial Sector Bond Funds

(UFBF)", is now being renamed to "UBL Income Opportunity Fund (UIOF)".

- 2. UBL FUND MANAGERS and the Trustee have agreed to further amend the Deed as authorized under Clauses 20.2 of the Deed.
- 3. The Securities & Exchange Commission of Pakistan ("SECP") vide its letter No. SCD/AMCW/UIOF/197/2015 dated 3rd December 2015 has approved the amendments to the Deed.

Amendments to the Trust Deed:

1. Cover Page:

The Title of the Fund is amended and read as follows:

"UBL Income Opportunity Fund (UIOF)"

2. Amendment in Clause 1:

Name of the Scheme is amended and read as follows:

UBL Income Opportunity Fund (UIOF)

3. Amendment in Clause 2(b):

Clause 2(b) is amended and read as follows:

(b)Benchmark

- i. The Benchmark of UBL Income Opportunity Fund shall be based on 75% six month Rolling average of 6-month KIBOR and 25% average 6-month deposit rate of three (3) banks rated A and above.
- Or any other benchmark as disclosed in the Offering Document of the Fund.

4. Amendment in Clause 11.1:

Clause 11.1 is amended and read as follows:

The Objective of UBL Income Opportunity Fund is to provide a competitive rate of return to its investors by investing in quality TFCs / Sukuk, Government Securities, Bank Deposits, and short and long term debt instruments.

5. All other contents of the Trust Deed shall remain unchanged and the Deed shall continue to remain in force and effect, amended as above.

For the purpose of Stamp Duty this Deed valued at Rs. 5,000/- and the prescribed Stamp Duty of Rs. 1,000/- affixed accordingly.
